## Types of Gifts you can designate for the future

**The most common legacy gift is a bequest.** In order to make a legacy gift to the Snow Leopard Trust, you will simply specify that the Snow Leopard Trust is to receive a certain amount or percentage of your estate, particular assets, or the remainder of the estate after providing for your heirs. We encourage you to discuss your desire to add the Snow Leopard Trust to your estate plan with your financial and/or legal advisor.

A general bequest is used to give a certain percentage or dollar amount of your estate.

A <u>specific bequest</u> directs that the Trust is to receive a specific non-cash item, such as shares of stock.

A <u>residual bequest</u> designates all or a portion of your estate to be given to the Trust after provisions have been made for your family, friends, and other bequests.
